

# DRIVER APPLICATION CHECKLIST

## Northern Territory



### Getting Started

1. Make sure you have a valid personal email address. This is where you will receive news and updates from Shebah HQ.
2. You will need to collect and familiarise yourself with the documents and information listed below, before you start your driver application with Shebah through our driver portal: <https://driver.icabbi.com/join-fleet/shebah/sign-up>. Read the Terms and Conditions for signing up.

4. Make sure any documents and photos you upload in the process of completing your driver application are under 2mb. Photos in particular can be quite large depending on the device used to capture them. Only use JPEG or PNG formats and PDF for long documents, such as your insurance.

### Documents You Will Need

- ☐ **To Start With, we'll need a clear photo of:**
  - The complete front of your car (plate clearly visible)
  - Front and Back of your Driver's Licence
- ☐ **Australian Business Number (ABN)**  
[Click here to apply for an ABN](#) (Individual/Sole Trader - you will be required to submit a quarterly BAS to the ATO)  
**You MUST BE registered for GST.**
- ☐ **Proof of Address**  
You will need to have a gas, electricity or household bill in your name.
- ☐ **Licence to Drive a Commercial Passenger Vehicle- (Hire or Reward 'H' Endorsement)**

  - You will need to complete a driver/rider knowledge test.

  - You will be required to complete a National Police Check.

  - You will also be required to complete a Medical Assessment of Fitness to Drive. [Complete the 'Medical Assessment of Fitness to Drive' form here](#)Once you receive the card in the post, you can upload it to the BADGE section.
- ☐ **Commercial Vehicle License**
  - Before you apply you will need to complete an Authorised Vehicle Inspection. Your car must be under 13 years old.

Upload a photo of your roadworthy certificate in the Car Road Worthy section. If your car is under 12 months old, you can upload the rego details. Your car must be under 13 years old.
- ☐ **Insurance**
  - Safety is our number one game which means your car must be insured.
  - Talk to your insurer about this and make sure to mention it is for rideshare purposes.
  - Please upload a copy of your full comprehensive insurance policy (usually 5-8 pages) in PDF format to the Insurance Policy section.

### Stripe: Your Payment Gateway

- ☐ Stripe is our third party payment system. You will receive an email to set this up via your driver portal.  
  
To complete Stripe set up, you will need:
    - Photo ID, Driver's licence or Passport
    - Proof of Address
    - Bank account details, account number and BSB
    - Select Individual/Sole Trader as the Business type and your name for the legal business name exactly as stated on your Australian Business Number (ABN). [You can lookup your ABN here](#).

### Tollways

- ☐ Set up an e-TAG account.  
Shebah recommends setting up an e-TAG account with a toll collection company. With an e-TAG in your car tolls will be automatically deducted from your account, reducing the risk of incurring additional fees from late toll payment. Passengers pay for tolls, so you're not out of pocket.
